First, I would like to thank those of you who were able to attend our 2013 Annual Meeting in September in Helena, MT. Besides the usual pest presentations and networking, this year's meeting also included extensive discussions on Japanese Beetle infestations, J.B. movement via nursery stock, as well as presentations on new topics such as agricultural incidents and regulatory communications.

Aurelio Posadas, National Plant Board's Executive Secretary, led us in a valuable discussion on Systems Approach to Nursery Certification (SANC) that included a visit with a local nursery in Helena. It was great for the attendees to be able to discuss the practical applications of SANC concepts with an active nurseryman and then be able to walk out and look at the nursery's Critical Control Points for pest introduction and what Best Management Practices are or could be in place.

In addition to representatives from 8 of the 13 western states, we also had representatives from the Central and Eastern chapters of HIS. Bob Buhler of Kansas and Michael Arnold of West Virginia provided great insights into the similarities and differences in what inspectors deal with across the country. A big thank you to Bob and Michael, and to the National Plant Board for continuing to provide travel funds for these types of cross-chapter activities.

## 13th ANNUAL MEETING - Helena, Montana

September 16th to 19th, 2013

#### ANNUAL MEETING SYNOPSIS

The venue for our 13th Annual Meeting was located in historic downtown Helena at the Holiday Inn. Guests enjoyed crisp fall weather with intermittent sunny skies.

Our meeting began with Donna Rise, Pest Management Bureau Chief, providing welcome and introductions. This was followed by participants providing reports from their respective states. The morning was capped off by a spirited discussion regarding Japanese Beetle introductions from the Mid-West and actions taken so far in an attempt to mediate infestations.

Dr. Jeaine Rankin, MSU Extension Service, presented Agro-Emergency Preparedness which is a part of national strategy for Homeland Security to include natural and agricultural resources. Unfortunately, agro-emergencies are not all that uncommon. Water contamination, animal disease (hoof & mouth, bird flu), plant pests (potato cyst), food contamination (*Salmonella/E. coli*), just to name a few, can seriously affect public health and jeopardize economic stability. Aurelio Pasadas, National Plant Board, provided Introduction to Systems Approach To Nursery Certification being developed through NPB. Key strategies of SANC are; Risk Analysis, Critical Control Points, Best Management Practices, Verification, and SANC Agreement. Aurelio also led the field trip to a local nursery and performed a mock "SANC Interview" with the nursery owner. http://sanc.nationalplantboard.org/

SR. Officer Gerald LaChere, Helena Police Dept., provided insight on Conflict Management/ Resolution. Conflict is a normal part of any healthy relationship. We need to learn how to deal with conflict rather than avoid it. People respond to conflict based on perceptions, which is not always the best solution. Use "I" statements, be assertive not aggressive, show respect, speak calmly and be willing to compromise.

Lori Witham, USDA-APHIS, shared insight on "Smuggling, Interdiction & Trade Compliance". The role SITC plays is to detect and interdict prohibited agriculture commodities from entering the US from foreign source. USDA, Plant Protection & Quarantine provided update on major pests of concern to include Emeralds Ash Borer, Japanese Beetle, Asian Longhorn Beetle and European Gypsy Moth. The focus of the presentation was recognizing pests, symptoms of infestation and the damage left behind. - 2012 WHIS Annual Business Meeting Minutes
  Motion was made by Beth Eiring and seconded by Beth Slate to approve the minutes as distributed.
  No objections. Motion carried.
- Treasurer's Report/Financial Audit

Beth Eiring informed the meeting that the Treasurer was not available (at this time in the meeting) and that the hard copies of the financial documents were recently received. Motion was made by Beth Eiring and seconded by Joshua Kress to audit the Treasurer's report by Friday, September 27th, 2012. No objections. Motion carried.

- Western Plant Board Meeting & Other Meeting Attendance Joshua Kress shared a summary, positive review, and feedback from the Western Plant Board Meeting in Honolulu, HI.
- Beth Slate provided a summary, positive review and feedback from the Kansas Interstate Inspection conducted last month. Robert Buhler offered that WHIS should consider extending the timeframe allotted and "ramp-up" the nursery inspection field trip day to a full 2-day trip which is common at the CHIS Annual meeting.
- Beth Eiring to attend EHIS in Mt. Holly, New Jersey in October. Joshua Kress reiterated that WHIS is allowed to use National Plant Board SANC funds for these interstate and inter-chapter HIS trips.
- Andrea Thompson volunteered to attend the CHIS Annual Meeting, October 21-24<sup>th</sup> in Lisle, Illinois. Motion was made and seconded to send Andrea using SANC funds. Motion carried without objections.

#### **Old Business**

#### Annual Meeting Handbook

Beth Slate suggested that there should be a rough outline for hosting and that the Annual Meeting Handbook is both helpful and beneficial. She also offers to work with Beth Eiring and

Andrea Thompson in collaboration developing this document. Robert Buhler states that he has a collaborative document between other HIS groups and could help with it. Beth Slate also suggested that it would be good to send out "Save the Date" reminders. Beth Eiring to lead all HIS Chapters in working on this at the President's Meeting.

#### **State Report Format**

It was generally agreed that obtaining the state reports early was a big success this year and presenting them during the conference day allowed for open discussion and helped promote acquaintanceship.

Joshua Kress mentioned that for next year it would be good to limit discussion of the California state report to the host county only and the overall state summary.

#### **New Business**

#### **Memberships / Meeting Registration Rates**

John Wraspir and Joshua Kress mutually offered that it may be worthwhile to incorporate the membership dues as part of the registration fees. Robert Buhler noted that the membership rates for the Central Chapter are only \$15 but that the fees are used to fund the hospitality room. They purposefully separate the membership dues from the registration fees so that there is no perception of illegitimate activities funded by state entities.

The question was then asked, "For the \$20 per year membership fee, what do you get?" Beth Slate stated that you are allowed to vote. Robert Buhler stated that people then have "skin in the game with access to the Listserve" Joshua Kress noted that the list of former members is very long and the list of current members is very short. John Wraspir mentioned that WHIS could boost attendance and membership by being more persistent about contact with those former and current membership lists by sending out a "We Miss You" card or survey.

John Wraspir proposed that there be a future events reminder being sent out. This duty falls in line with those of the Secretary and Andrea Thompson is therefore responsible to carry it out.

#### 2014 WHIS Annual Meeting Location

Joshua Kress stated that it would be beneficial and ideal to have the meeting location for future years planned out at least two to three years in advance. He continued that in January there is a CASAP conference performing a border tour in San Diego, California. Combined with the fact that California is the #1 nursery producing state in the nation, he recommended that San Diego, California be the location for the 2014 WHIS Annual Meeting. Motion was proposed by Beth Slate and seconded by Andrea Thompson for San Diego, California to be the 2014 WHIS host. Motion carried without objection.

John Wraspir asked Karen Melvin if the 1<sup>st</sup> or 2<sup>nd</sup> week of October would be okay for the date. She replied affirmative. He also asked her who would be the main point of contact as typically the Vice President plans the meeting and is from the host state. Karen stated that she would have to get back with WHIS about a main point of contact because they see themselves as assisting but not being in charge of the meeting or holding a role in the WHIS Executive Committee.

#### 2015 & Beyond WHIS Annual Meeting Location

Andrea Thompson recommended Boise, Idaho as the location for the 2015 WHIS Annual Meeting. Idaho's largest industry is agriculture and Boise is easily accessible with a regional airport and has many retail and wholesale nurseries within an hour drive of downtown.

Motion was made and seconded for Boise, Idaho to be the 2015 WHIS host. Motion carried without objection.

The 2016 WHIS Annual Meeting host state was tentatively agreed to be Arizona without motion. There are still other suggestions for other locations. Some more or less involved in agriculture and horticultural production. It is suggested that Aurelio Posadas can entice Arizona to play an active role, especially, with their relative proximity and likelihood of attendance at the 2014 San Diego, CA meeting.

Beth Slate stated that WHIS should offer a scholarship to AZ for the 2014 meeting. Motion proposed by John Wraspir to offer at least two \$500 scholarships, especially to AZ and OR to promote attendance. Motion was made, seconded and carried without objections.

A general question remains about establishing a set list rotation of host states excluding Alaska & Hawaii.

A motion to accept the nominations named above was made and passed without objection. Joshua Kress and Beth Slate noted that they would be staying involved in a support role to assist the new Executive Committee.

#### Adjournment:

Joshua Kress, Immediate Past President, and Beth Eiring, newly elected President, thanked the officers for their work throughout the year, and Montana for being a gracious host state. The gavel was passed to the new H.I.S. Western Chapter President, Beth Eiring of California informally after the meeting adjourned. Joshua & Beth thanked all attendees for their participation and involvement that lead to the success of this year's meeting. A motion was made and seconded to adjourn the meeting at 12:45 p.m.
