

### 16th ANNUAL MEETING—Albuquerque, New Mexico

Annual meeting plans are complete and preparations are under way for our 16<sup>th</sup> Annual Meeting that will be based out of the Hotel Albuquerque at Old Town. This is a truly unique venue in New Mexico, celebrating Albuquerque's culture and history. The hotel design exemplifies Albuquerque architecture, blending New Mexico's Native American, Mexican, Spanish and Western cultural influences. The building's turn-of-the-century elegance also draws on classic territorial details, prevalent in New Mexico historical buildings and Albuquerque architecture. The hotel grounds include a 19th century-style chapel and courtyard, as well as Spanish gardens and a Victorian-style pavilion.

#### COME AND JOIN US !

**Old Town** is the focal point of community life since it was founded in 1706 by Governor Francisco Cuervo y Valdez. Centered around the plaza, Albuquerque's Old Town encompasses about ten blocks of historic adobe buildings. On the north side of the plaza is the San Felipe de Neri Church, the oldest building in the city, which was built in 1793. Surrounding the church, the city's settlers had built their homes, shops and government offices, many of which have since been converted into the restaurants, art galleries and shops that comprise Old Town today.

There will be plenty of time after meeting events to take a walking tour and experience the essence of New Mexico.


#### Stay Informed

Dr. Brian Bahder, UC Davis, has confirmed and announced, and will soon be publishing that the "Threecornered Alfalfa Hopper" *Spissistilus festinus* is a vector for Grapevine Red Blotch-associated Virus (GRBaV) in wine grape vineyards. Until now the vector for this disease has remained elusive. Red Blotch can dramatically affect quality by reducing sugar content and can lead to reduced color.

#### Spissistilus Festinus Description

**Egg:** The white, oblong-oval egg is 0.90 to 1.3 mm long. It is slightly larger at one end, and that end has a rough surface.

**Nymph:** Mature nymphs are lime green with obvious spines along the back, 4.6 mm long.

**Adult:** The adult male is slightly smaller than the female, 6.0 to 6.5 mm and has a red or orange strip on the shoulders.
