Zebra Mussels and Aquarium Moss Balls

Zebra mussels have been found in aquarium moss balls sold in pet stores earlier this year. The USFWS and USGS are working with pet stores and other organizations to mitigate the spread of this invasive pest. ODA News reported that an emergency rule was filed to control the entry of moss balls into Oregon after zebra mussels were found.
